Monthly Pre-Filing Status Report

Ladies and Gentlemen:

Florida Southeast Connection, LLC ("FSC") hereby files this Monthly Status Report for the Florida Southeast Connection Pipeline ("Project") for activities conducted from initiation of the pre-filing process to November 30, 2013.

Project Scope and Schedule

No changes in project scope or schedule have occurred since the Commission approved FSC's request to enter the pre-filing review process on October 16, 2013 and the subsequent submittal of Resource Report 1 and Resource Report 10 on November 15, 2013 and the Revised Resource Report 10 on November 27, 2013. Two alternate routes (Alternate Routes 1 and 2) and three deviations of the proposed route (Route Deviations 1, 2 and 3) are currently being evaluated. FSC continues to examine minor route adjustments to the proposed route as additional survey and stakeholder information is received.

Environmental & Cultural Resource Surveys

Environmental and cultural resource surveys continue to progress from Polk County, Florida through Okeechobee, Osceola, St. Lucie Counties and into Martin County, Florida. Environmental field and cultural crews have field surveyed 79% or provided desktop analysis on the remaining 21% of the proposed route. A total of 47 archeological sites and potential historic district are currently being evaluated for historical significance on the proposed route.

Agency Consultation

Agency meetings that occurred from initiation of the project through November 30, 2013 are provided in the attached Florida Southeast Connection Master Meeting List.

State and Federal Permits and Clearances

There are no updates or modifications to the list of major state and federal environmental permits and clearances previously filed for the Project.

Landowners

FSC continues to make notifications to landowners as the proposed route, alternative routes, and access roads are updated. FSC is actively working with individual landowners to address their concerns regarding routing on their property as access is granted. The following list summarizes the status of survey activities to date:

- **Survey Permissions:**
 - 695 Tracts in Survey Corridor
 - 76% Tracts Granted Access for Environmental Surveys
 - 79% of Route Granted Access for Environmental Surveys

- **Status of Field Surveys:**
 - 100% Civil Surveys Completed on the Proposed Route
 - 100% Environmental Surveys Completed on Accessible Parcels
 - 100% Cultural Resource Surveys Completed on Accessible Parcels
 - Environmental and Cultural Resource Surveys on Access Roads and Potential Storage Yards began November 4, 2013 and should be complete in early December

Public Outreach

FSC's outreach team continues to meet with state, county, and municipal officials in the areas potentially affected by the Project. The outreach team will continue its efforts to keep the community leaders in the project area informed of Project activities. On October 29, 2013, FSC mailed Project Open House Letters to stakeholders within 300 ft. of the proposed centerline of the pipeline. Notices were also published in the local newspapers inviting the public to the Open Houses.

Project Open Houses occurred on the following dates and locations:

- November 12, 2013 – Kenansville Community Center, Osceola County, Florida
- November 13, 2013 – Haines City Banquet Hall, Polk County, Florida
- November 14, 2013 – Lake Wales Art Center, Polk County, Florida
- November 19, 2013 – Indiantown Civic Center, Martin County, Florida
- November 20, 2013 – St. Lucie County Fairgrounds, St. Lucie County, Florida
- November 21, 2013 – Quail Creek Plantation, Okeechobee County, Florida

A total of 294 people attended the FSC Open Houses. The response from the public was mostly positive with a few land owners raising questions and concerns. In addition to landowner specific requests for route adjustments, the following is a summary of the types of questions and comments received from landowners.

- Is there a potential for future pipeline interconnections for local natural gas service?
- Can you provide more detail on pipeline route?
- What is the construction timeline?
- Bad experience with recent transmission line construction
- How long does the actual construction process on my property last?
- What condition will the property be in after construction?

- When will easements be purchased, at what phase would discussions begin?
- Define if the survey corridor width is 600 feet or 300 feet?
- Will gas being transported via the pipeline come from fracked sources?
- Can residents be paid yearly for their right of way easements?
- What steps are being taken to avoid old growth trees (oaks and other hardwoods) on property, and can the route be negotiated?
- Potential housing/accommodations was identified and offered for pipeline workers.
- Will there be opportunities for local residents to work with pipeline contractors?
- Will vehicle storage for contractors occur on landowner property?

FSC has received one public comment filed in FERC Docket PF14-2 regarding potential impact of the proposed pipeline to cemeteries in Indian River and Osceola Counties. FSC has determined that the proposed route will not impact the cemeteries.
